



CALL FOR ABSTRACTS

Submission Deadline: 1 April 2023

It is our pleasure to invite you to the 11th European Conference on Injury Prevention and Safety Promotion (EU-Safety 2023) in Reykjavik, 05 - 06 October 2023, organised by EuroSafe in collaboration with the Icelandic Association for Search, Rescue, and Injury Prevention (ICE-SAR) The series of European Injury Prevention Conferences provides training and exchange opportunities for injury researchers and safety promotion practitioners across Europe.

Topics of interest

This year the main theme is "Mind the gap - Putting Injury Prevention Research into Practice" The conference will:

- Highlight the achievements in injury prevention, review progress made in injury surveillance and research and in national and local safety promotion programmes across Europe
- Feature risk control in outdoor and adventure sports, as well as trends and technologies in outdoor rescue
- Demonstrate good practices in prevention, including key priority areas such as child safety, consumer product safety, safety for older people, and safety of vulnerable road users
- Reinforce collaboration between experts across Europe and within existing networks, such as the network for injury surveillance (EU-IDB)

Cross-cutting issues will be addressed in plenary sessions, alternated by concurrent breakout and e-poster sessions addressing topical issues such as those listed above.

Who should participate?

The conference will bring together people with a professional interest in injury prevention and safety promotion, including:

- Decision makers in local, regional, and national governments
- Professionals working in public and private institutions responsible for health and safety, health promotion, consumer protection, housing, urban planning, and education
- Researchers in academic institutions, institutes of public health, research institutions, and statistical offices
- Professionals working in private businesses, e.g. in product design, manufacturing and services, or in health, care, and welfare services

Abstract submission

- All abstracts must be submitted electronically before 1 April 2023 (max. 400 words in English Please follow the instructions in the online submission form)
- Abstracts will be reviewed by at least two members of the Programme Committee
- Authors will be notified of acceptance as of 15 May 2023
- Abstract authors must register for the conference before 15 June 2023 (registration ensures publication and presentation)
- All accepted abstracts will be published in an abstract book on the conference website after the event
